## **REACH Conformity Declaration Regulation (EC) No. 1907/2006 of the European Parliament**

Krekeler & Losch functions pursuant to EC Regulation 1907/2006 (REACH-Regulation) as a downstream user (producer of articles).  
Our business activities include the production of turned parts (metal products) according to customer requirements based on the use of standard materials.

Pursuant to Article 33 of the REACH Regulation the duty to inform is given in as far as manufacturing substances are classified as being substances of very high concern (SVHC). Lead has been included as a SVHC in the candidate list since 27.06.2018. We would like to inform you that our turned parts which have a lead content of greater than 0.1% by weight, contain lead metal (CAS 7439-92-1) identified as a substance of very high concern (SVHC), see candidate list <https://echa.europa.eu/candidate-list-table>.

According to information from our material suppliers, classification under the regulation on hazardous substances, the rules on safe handling and the range of applications with lead as an alloy constituent remain unaltered.  
As specified by our supplier for packaging our packaging equipment is compliant with REACH.

PBT substances are not contained in our products (PBT not relevant for metals.)

In as far as substances are classified as SVHC, we will comply with our obligation to provide information.
